Under the UK's reformed Packaging Waste Regulations - packaging [Extended Producer Responsibility](#), companies that handle more than 25 tonnes of packaging and have an annual UK turnover of over £1 million, are required to report on their activities, and may have to financially contribute to material recycling, recovery, and disposal, as well as raising awareness among consumers.

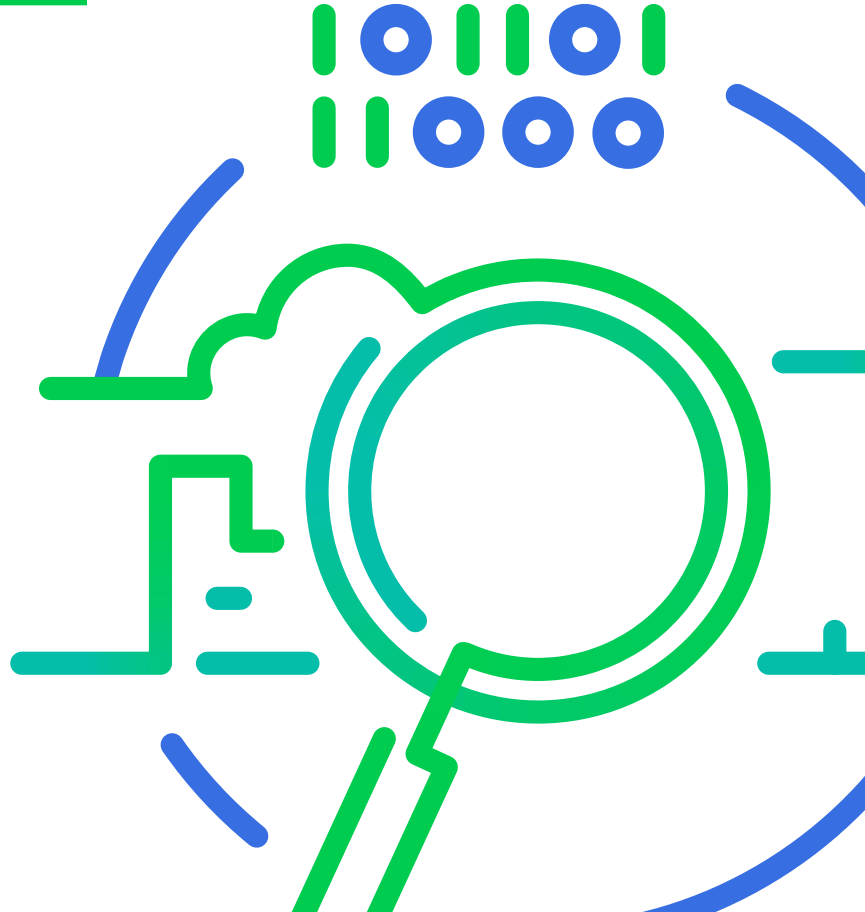

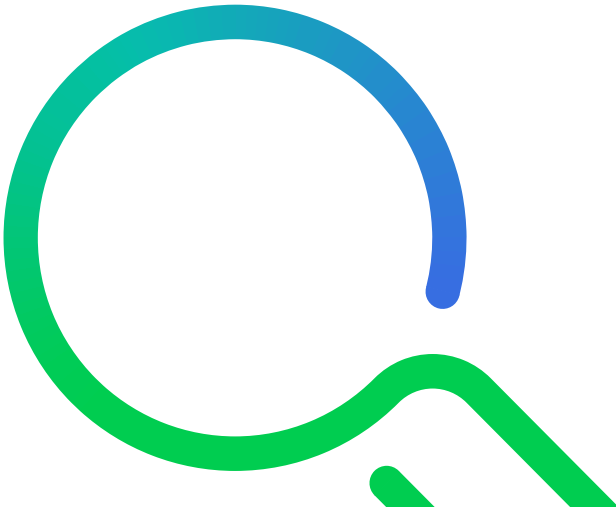

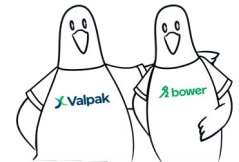
