An introduction

The Better Cotton Initiative (BCI) is a global nonprofit organisation dedicated to promoting sustainable cotton production. The initiative aims to make cotton farming better for the environment, the farmers, and the communities where it's grown. It focuses on reducing the negative environmental impacts of cotton production, improving livelihoods and economic development in cotton-producing areas, and promoting fair working conditions.

BCI works with farmers to adopt more sustainable practices, such as minimising the use of pesticides, optimising water usage, and promoting soil health. By meeting the standards set out by BCI, farmers produce "Better Cotton," which is then purchased by brands and retailers that are committed to sustainability. Today, BCI is the largest cotton sustainability programme in the world, representing a significant portion of the global cotton supply.

Purpose of a BCI Measuring Cotton

Consumption Independent

Assessment.

The purpose of a Better Cotton Initiative (BCI) Independent Assessment is to verify the accuracy and reliability of your business's cotton consumption data and ensure that it complies with the requirements set out by BCI. The independent assessment is only applicable to BCI's Retailer and Brand Members (RB Members).



The process.

Valpak will conduct an independent assessment, which includes:

- Reviewing your, cotton fibre consumption submission form which needs to be submitted to BCI by the 15 of January each year.
- Reviewing all records related to your business's cotton fibre consumption measurement in an electronic format
- Reviewing the 'documented protocol' of how the records are used to create the cotton fibre consumption measurement.

The audits are conducted online, and the requirement and frequency will be based on your business's size category. Once the independent assessment has been completed Valpak will provide the you with a signed Outcome Declaration and Conformity Assessment which must then be submitted to BCI before the annual deadline.

How are member size categories and assessment frequencies defined?

Membership size categories are based on the annual volume of cotton a RB Member consumes or processes. These categories determine the frequency and requirements for BCI independent assessment:

The requirements.

From January 2024, RB Members are required to, alongside submitting cotton fibre consumption data annually, commission a Third Party to assess the accuracy and reliability of these measurements. The requirement and frequency of the Independent Assessment is based on your membership size category outlined earlier and therefore, your total amount of cotton fibre consumption.

To conduct the independent assessment, we would require the following documents:

- Completed Better Cotton's Annual Cotton Consumption Submission Form (covering the most recent consecutive 12-month period only) which needs to be submitted to BCI by the 15 January each year.
- All records related to your cotton fibre consumption measurement in an electronic format suitable to Valpak. Typical records include:
 - Raw data (spreadsheets, database extracts, associated database filters)
 - Calculation models (spreadsheets, or programming code)
 - o Methodology records detailing, for example, the calculation logic (how raw data is transformed into results) and explanations for how they ensure BCl's requirements 3a 3h are met
 - o Records of assumptions, e.g., approaches taken for filling gaps that may be present in the raw data
- Documented protocol which should consist of a written explanation of how the records have been used to arrive at the final measurement

Once the independent assessment has been successfully completed and any non-conformities rectified Valpak will provide the you with a signed Outcome Declaration and Conformity Assessment which can be submitted to BCI before the annual deadline.
